
#### **OUR MISSION**


# INTRODUCTION





## Introducing Bagus Platform

Bagus Platform consists of two main programs, namely: Bagus Wallet and Bagus Exchange. Bagus Exchange is a new defi platform that facilitates trading of asset chains that represent the real economy. Our commitment to the Binance ecosystem and native implementation on the Binance Smart Chain (BSC) offers users speed and currently less reliance on the Ethereum blockchain.



# About Bagus Wallet

Bagus Wallet is made with multi-chain and separate network options by prioritizing security, easy-to-use wherever and whenever. The team launched the Android version of Bagus Wallet in the early stages and continued development on the IOS version. Bagus Wallet will continue to be developed as blockchain technology develops.



## About BagusToken

BagusToken (BG) was developed under the BinanceSmartchain network (BEP20) to function as part of an economic incentive for participants on the Bagus Platform. The BG Token is also part of a tradable crypto asset, and is used in Community Staking to manage the overall protocol and the future development of the Bagus Platform. The developer of Bagus Platform is committed to presenting a Decentralized (DEX) Exchange called "BagusExchange" which will be presented using the BinanceSmartchain network (BEP20). The developer provides BagusExchange in a website version and can also be accessed through the Dapps application.



#### App Wallet & Dex

Development of our iOS/Android Web App & Mobile app featuring decentralized exchange, watch assets, live charts and historical data. Our goal is to provide a cryptocurrency exchange that offers its users the ability to easily buy, sell and exchange any cryptocurrency at any time. We will have a vetting process that will ensure the cryptocurrencies in our marketplace are not scams or malicious.

# Staking

- BG Token holders are incentivized to stake their tokens into a community-based liquidity pool
  that will collateralize rewards.
- BG stakers are rewarded with BG staking rewards, which is generated from the token's inflationary monetary policy, and exchange fees from the Bagus Exchange.
- Each transaction on the Bagus Exchange incurs up to a 0.3% exchange fee that will be distributed to BG stakers at a rate proportional to their position size within the liquidity pool.




